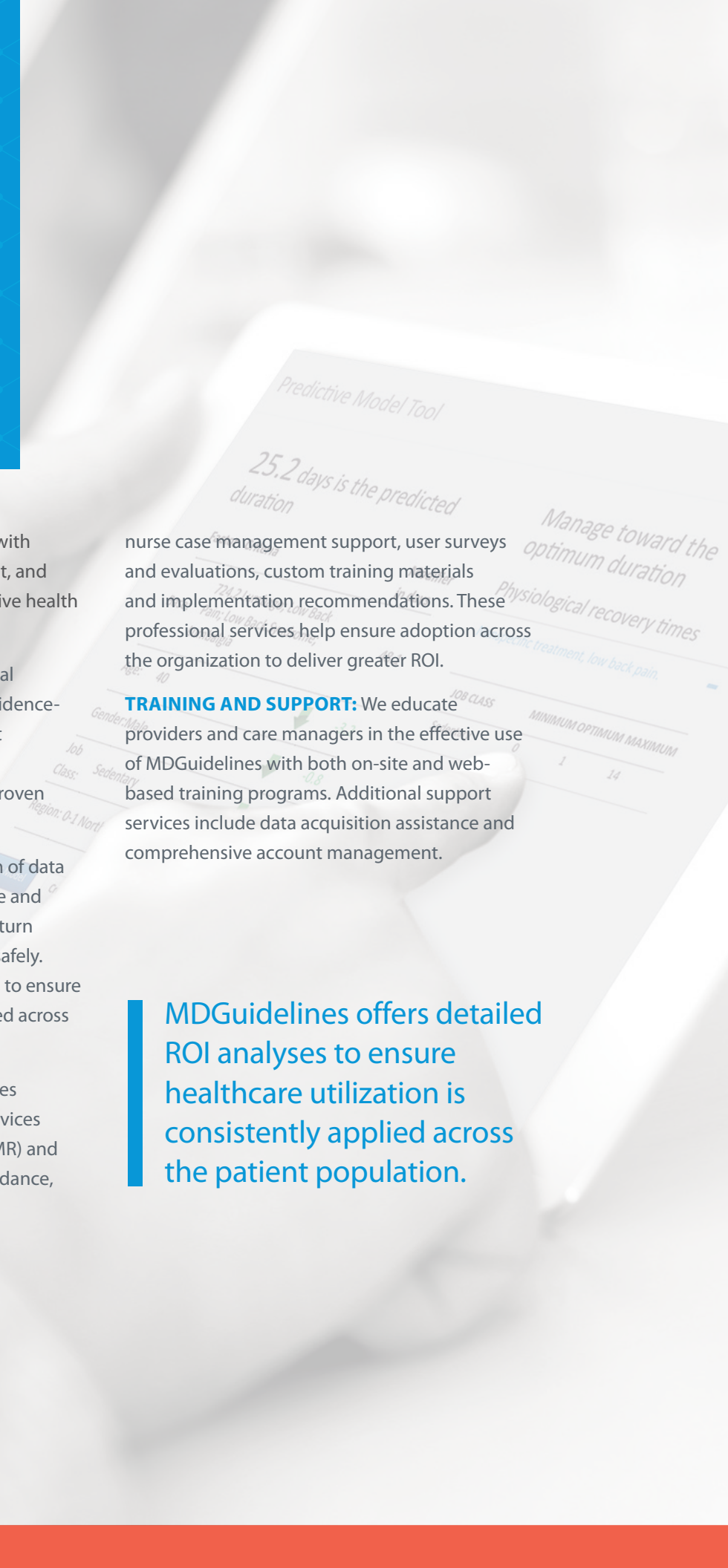

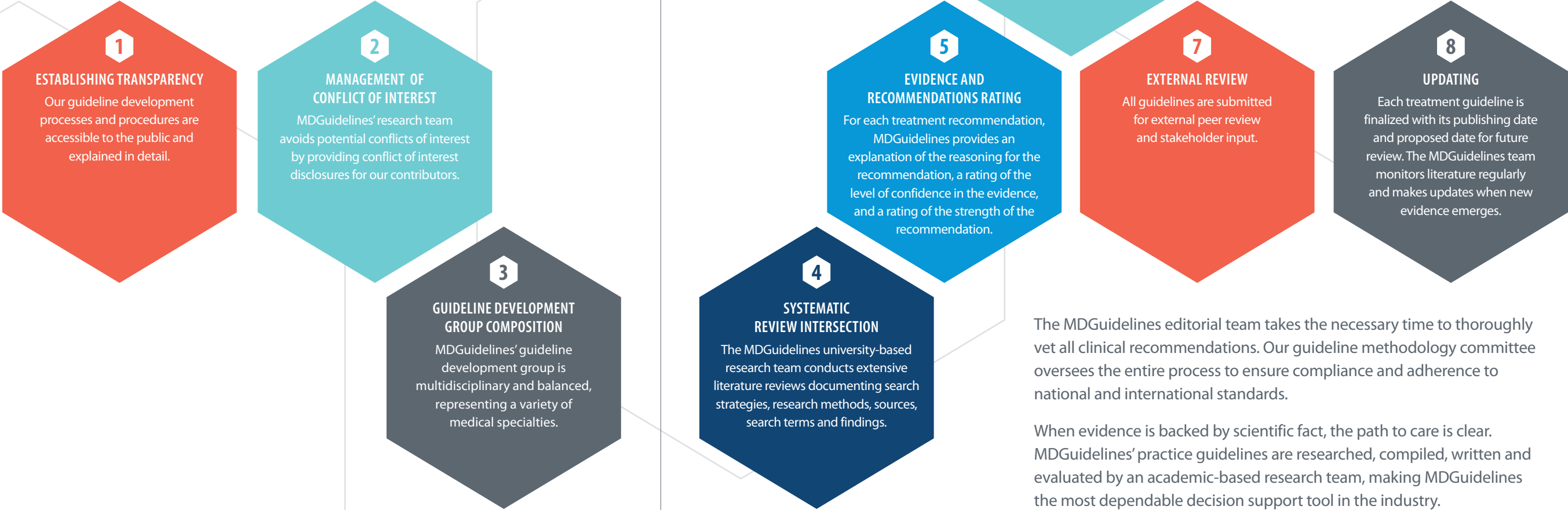

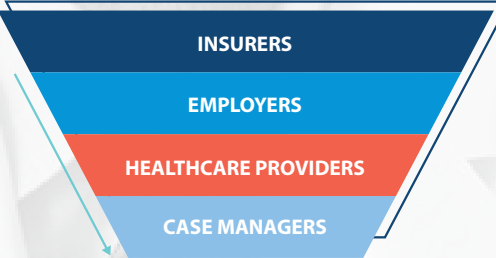
DISCOVER THE BEST-IN-CLASS DATA BEHIND MDGUIDELINES

PHYSIOLOGICAL DURATION TABLES: Informed by data and clinical expertise, our duration tables are created by the MDGuidelines Medical Advisory Board and provide physiological recovery timeframes. These gold-standard duration guidelines represent “uncomplicated” cases and are tiered according to the activity level of the injured or ill patient.


POPULATION DATABASE: Serving as the foundation of MDGuidelines, the database leverages a proprietary collection of more than 15 million real-world illness and injury cases, covering more than 13,000 diagnoses. Our Population Database is the largest of its kind in the industry.

PREDICTIVE MODEL: Our predictive model presents a “case-specific” view of a duration estimate by allowing the user to query the Population Database by medical code and control for variables such as age, gender and comorbidities. The resulting predicted values are a helpful benchmark to see what can happen when a case isn’t properly managed to the physiological duration.
